Compressive Strength: <u>Average 7,000 psi</u> Water Absorption: 5% - 6%

Freeze Thaw: Less than 1% loss of dry weight (50 cycles)

and will correct defects in surface, color and/or texture caused by poor workmanship during the manufacturing process. Tile Tech Pavers obligations during the warranty period is limited to the original cost of the pavers only.

TERMS, CONDITIONS AND LIMITATIONS OF THIS LIMITED WARRANTY

- A. Use of Tile Tech Pavers products constitutes acceptance of materials.
- B. Tile Tech Pavers assumes no responsibility for the paver installation for any reason whatsoever.
- C. During the terms of this warranty, Tile Tech Pavers, shall have access to the project for inspection during normal business hours.
- D. Written approval by owner to Tile Tech Pavers is required before making any modifications to Tile Tech Paver products or installing any structures, fixtures or utilities on or through the units.
- E. Written notice by owner to Tile Tech Pavers is required within thirty (30) days of completetion of installation as to discovery of defects of pavers for any claim under this warranty.
- F. Damage or loss caused by the following factors, conditions or events are not covered by this warranty.
 - 1. Natural disaster, including, but not limited to, earthquakes, floods or other similar natural disasters.
 - 2. Vandalism, acts of war or civil disobedience.
 - 3. Settling or other movements or failure of the structure or failure of other components to which the Tile Tech Paver products are set upon.
 - 4. Environmental fallout or manufacture in the project of commercial/industrial solvents, acids, oils, waxes, greases, bleaches, caustic materials or plasticizers that may cause damage to the floor.
 - 5. Acts of negligence or misuse by parties other than Tile Tech Pavers.
 - 6. Failure by owner or leasee to use reasonable care in maintaining the Tile Tech Paver products.
- G. In the event of failure of Tile Tech Paver products withinin the scope of this warranty, Tile Tech Pavers will remanufacture the failed product only. In no event shall Tile Tech Pavers obligation over the life of this warranty exceed the original cost of the product. The remedy stated herein is the SOLE AND EXCLUSIVE REMEDY for failure of the pavers. TILE TECH PAVERS SHALL UNDER NO CIRCUMSTANCE BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING, BUT NOT LIMITED TO, DAMAGE TO THE PROJECT OR THE CONTENT OF THE PROJECT.
